The Assembly amendments incorporate changes to Section 25247 of the Health and Safety Code proposed by AB 1611 and SB 839 contingent on the prior enactment of one or both of those bills.

**Legislative Counsel's Digest of Assembly Amendments**

SB 1072, as it passed the Senate, required that procedures to ensure that a pupil is not left unattended on a schoolbus, school pupil activity bus, or youth bus be included in the transportation safety plan required to be prepared by certain entities. SB 1072, as it passed the Senate, required the governing board of a school district to require that any contract for the transportation of pupils include the requirement that a pupil shall not be left unattended on a schoolbus, school pupil activity bus, or youth bus, as provided. SB 1072, as it passed the Senate, required that the classroom instruction required to be completed by applicants seeking to renew a certificate to drive a schoolbus or a school pupil activity bus also cover inspection procedures to ensure pupils are not left unattended on a schoolbus or school pupil activity bus. SB 1072, as it passed the Senate, required certain school officials to notify the Department of Motor Vehicles when a driver of schoolbus, school pupil activity bus, or youth bus has left a pupil unattended onboard, and authorized the department to refuse to issue or renew, and to revoke or suspend, a bus driver certificate on these grounds. SB 1072, as it passed the Senate, required, on or before the beginning of the 2018–19 school year, schoolbuses, school pupil activity buses, and youth buses to be equipped with a “child safety alarm system,” which is a device located at the interior rear of a vehicle that requires the driver to manually contact the device before exiting the vehicle, thereby prompting the driver to inspect the entirety of the interior of the vehicle before exiting.

The Assembly amendments revise the procedures that certain school officials are required to follow before they notify the department that a driver of schoolbus, school pupil activity bus, or youth bus has left a pupil unattended onboard. The Assembly amendments permit a former applicant or holder of a bus driver certificate whose certificate was revoked on those grounds to reapply for a certificate if the certificate revocation is reversed or dismissed by the department. The Assembly amendments require the transportation safety plan to also include procedures and standards for designating an adult chaperone, other than the driver, to accompany pupils on a school pupil activity bus, and require a charter school to prepare this plan. The Assembly amendments change the name “child safety alarm system” to “child safety alert system,” revise the requirements for that system, and require child care motor vehicles, as defined, to be equipped with that system. The Assembly amendments provide that a school pupil activity bus is not required to be equipped

SB 1090, as it passed the Senate, replaced the term “venereal disease” with “sexually transmitted diseases” (STD’s), defined as diseases that are primarily transmitted through sexual contact. SB 1090 also required the State Department of Public Health, as specified, to allocate grants to local health jurisdictions for STD outreach and screening services. SB 1090 also required the department to authorize innovative and impactful services, as specified.

The Assembly amendments instead require the department to allocate grants to local health jurisdictions for STD outreach, screening, and other core services. The Assembly amendments also instead provide that in awarding funds, the department may authorize innovative and impactful outreach, screening, and other core services, as specified. The Assembly amendments also state the intent of the Legislature that the identified services enhance the services that are already provided.

**Legislative Counsel’s Digest of Assembly Amendments**

SB 1466, as it passed the Senate, required screening services provided under the Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) benefit within the Medi-Cal program for individuals under 21 years of age to include screening for trauma, as defined. SB 1466, as it passed the Senate, required that a child who was removed from the custody or care of his or her parent or legal guardian be assessed by the county mental health plan for specialty mental health services.

The Assembly amendments require the State Department of Health Care Services to adopt, employ, and develop tools and protocols for the screening of children for trauma, as specified, and authorize the department to implement, interpret, or make specific this provision by means of all-county letters or other specified instructions. The Assembly amendments require that the screening for trauma under the EPSDT benefit be consistent with the protocols developed by the department. The Assembly amendments also make changes to the definition of “trauma.” The Assembly amendments delete the above provision relating to an assessment by the county mental health plan for specialty mental health services.

SB 777, as it passed the Senate, also required information to be supplied on the amount of remuneration to persons other than directors and officers in excess of \$95,000.

The Assembly amendments, instead, until January 1, 2022, exempt a person who makes one commercial loan in a 12-month period from regulation pursuant to the California Finance Lenders Law.

An act relating to health and care facilities.

**Legislative Counsel's Digest of Assembly Amendments**

SB 648, as it passed the Senate, required a referral agency to obtain a license from the State Department of Social Services in order to refer a person to a residential care facility for the elderly and prohibited an extended care facility, skilled nursing home, intermediate care facility, or residential care facility for the elderly from paying a commission or fee to a referral agency that is not licensed. SB 648, as it passed the Senate, required a referral agency to provide a specified disclosure statement to each person receiving its services and to retain the acknowledgment from the person being referred, or his or her conservator, guardian, authorized family member, or agent under power of attorney, for 3 years. SB 648, as it passed the Senate, made failure to provide the disclosure statement or retain the acknowledgment, with the intent to mislead the public on the nature of services provided, unfair competition, subject to a civil penalty of up to \$2,500.

The Assembly amendments, among other things, authorize the State Department of Social Services to set an annual Licensing and Certification Program fee at an amount no greater than the amount required to cover the reasonable and actual costs of administering the program and require the department to annually submit a proposed fee schedule, as part of its budget proposal, to the Legislature. The Assembly amendments add to the information required to be provided by a licensed referral agency in its application, including a declaration that the licensee will either conduct a suitability determination, as defined, or that the licensed referral agency will disclose that it does not determine whether the recommended facilities are suitable. The Assembly amendments state that an applicant is not required to have a physical place of business in the state. The Assembly amendments make it unlawful for an employee, independent contractor, or other person who is acting on behalf of a government agency, hospital, or other health care institution to offer, provide, or accept payment, rebate, refund, commission, preference, or discount as compensation or inducement for referring people to a facility or a licensed referral agency. The Assembly amendments make the owners, operators, and employees of referral agencies mandated reporters of elder or dependent adult abuse.

The Assembly amendments request that the University of California complete that study until January 1, 2021, and request that it post the report of the study on its Internet Web site no later than January 1, 2018. The Assembly amendments require the Department of Motor Vehicles to post on its Internet Web site, and any other appropriate online venue used by the department for public outreach, detailed instructions for motorists that describe how to prevent theft of month and year vehicle registration tabs.

**Legislative Counsel's Digest of Assembly Amendments**

SB 819, as it passed the Senate, prohibited the Department of Alcoholic Beverage Control from issuing a license to manufacture, distribute, or sell powdered alcohol, as defined, and required the department to revoke the license of any licensee who manufactures, distributes, or sells powdered alcohol, as provided. SB 819, as it passed the Senate, also prohibited the possession, purchase, sale, offer for sale, distribution, manufacture, or use of powdered alcohol and made the violation of these provisions punishable as an infraction, thus imposing a state-mandated local program.

The Assembly amendments remove the provision prohibiting the Department of Alcoholic Beverage Control from issuing a license to manufacture, distribute, or sell powdered alcohol and remove the provision imposing an infraction for the possession, purchase, or use of powdered alcohol.

S.B. No. 887—Pavley et al.

An act relating to natural gas.

**Legislative Counsel's Digest of Assembly Amendments**

SB 887, as it passed the Senate, among other things, required a natural gas storage well, before January 1, 2018, and annually thereafter, to be tested across its entire length for a loss of integrity resulting in a leak and to have those results reported to the Division of Oil, Gas, and Geothermal Resources in the Department of Conservation, and prescribed standards for a natural gas storage well, including, among other things, a requirement that the well be equipped with an automatic downhole shutoff system, and required baseline and follow-on proactive evaluations. SB 887, as it passed the Senate, required the division to convene an independent panel of recognized experts to develop best practices for natural gas storage facilities, to review and incorporate the best practices developed by the panel into its regulations for natural gas storage wells and other wells, to periodically, and whenever necessary, review advances in relevant technologies and best practices for natural gas storage facilities, and, if appropriate, to incorporate changes in best practices into its regulations for natural gas storage wells and other wells, as specified. SB 887, as it passed the Senate, required the Office of Environmental Health Hazard Assessment and the State Department of Public Health, in consultation with the division, to perform a risk assessment of natural gas storage wells to determine appropriate setback distances for natural gas storage wells and to report the findings of the risk assessment to the Legislature. SB 887, as it passed the Senate, provided that the public has a right to review the locations of all new natural gas storage wells or existing wells converting to natural gas storage wells before the approval of the notice; required the well history to include all operations, injection, production, and emplacement of any materials into a natural gas storage well and to be disclosed to the division by the operator, as specified; and provided that a violation of the prohibition against the unreasonable waste of natural gas is subject to civil penalty not to exceed \$25,000 for each violation.

The Assembly amendments substantially recast and revise those requirements to, among other things, require the operator of a gas storage well, before January 1, 2018, to have commenced a mechanical integrity testing regime specified by the division; impose requirements on the division, the State Oil and Gas Supervisor, and operators of natural gas storage wells related to reportable leaks and the storage of natural gas; and revise requirements relating to required comprehensive gas storage well training and mentoring programs, risk management plans, and a natural gas

storage facility monitoring program. The Assembly amendments additionally revise the computation of an annual charge on operators of underground gas storage facilities to instead require that annual charge to be the proportionate share of the total regulatory costs projected for each fiscal year based on the field capacity and number of wells of each underground gas storage facility, as specified, and require an additional charge to be imposed on an operator, if an uncontrolled leak or release of gas occurs at the operator's underground gas storage facility, to defray the costs of the response effort of the division, as specified. The Assembly amendments, until January 1, 2019, additionally require that emergency regulations adopted by the division effective February 5, 2016, continue in effect until the adoption, amendment, or repeal of the regulation is promulgated by the division pursuant to the Administrative Procedure Act. The Assembly amendments additionally require the Public Utilities Commission, if a new underground gas storage facility is proposed, to ensure that a risk assessment evaluating the potential impact of a leak from the facility on public and environmental health, safety, and welfare is conducted by the project proponent, as specified, and require that the findings of any risk assessment conducted pursuant to these provisions be subjected to peer review by independent experts and reported to the Legislature, as specified.

S.B. No. 888—Allen et al.

An act relating to gas corporations.

### Legislative Counsel's Digest of Assembly Amendments

SB 888, as it passed the Senate, required the Public Utilities Commission to deposit moneys from penalties assessed against a gas corporation in regards to a gas storage facility leak into the Gas Storage Facility Leak Mitigation Account established in the State Treasury. SB 888, as it passed the Senate, provided that moneys in this account shall be expended, upon appropriation by the Legislature, solely for direct emissions reductions in furtherance of the achievement of the greenhouse gas emissions limit, as specified. The bill would require the State Air Resources Board to determine the amount of gases emitted by a leak for these purposes.

The Assembly amendments would revise and recast those provisions to require, if sufficient moneys remain after mitigating the impact on the climate from the gas corporation's emissions, that the moneys be expended to reimburse state and local response costs; to require these moneys to be expended in a manner that achieves a reduction in greenhouse gases that will fully offset the impact on the climate from those gases emitted by the leak and in accordance with provisions requiring specified allocations to disadvantaged communities; and to require that moneys in the fund resulting from penalties assessed for the Aliso Canyon gas leak be expended, consistent with the state board's Aliso Canyon Climate Impacts Mitigation Program, for specified purposes. The Assembly amendments require the state board to determine the amount of, and impact on the climate from, greenhouse gases emitted by a leak for these purposes. The Assembly amendments require a penalty assessed against a gas corporation pursuant to the Public Utilities Act in regards to a natural gas storage facility leak to at least equal the amount necessary to fully offset the impact on the climate from the greenhouse gases emitted by the leak from the natural gas storage facility, as determined by the state board, and require the commission to consider the extent to which the gas corporation has mitigated, or is in the process of mitigating, the impact on the climate from greenhouse gas emissions resulting from the leak, as specified. The Assembly amendments also make nonsubstantive changes to these and other provisions.

**Legislative Counsel’s Digest of Assembly Amendments**

SB 900, as it passed the Senate, required the State Lands Commission to, within 2 years, administer a coastal hazard removal and remediation program, as specified, upon appropriation of moneys by the Legislature for the program.

The Assembly amendments revise the definition of “coastal hazards” for purposes of the program and require the commission to prioritize its activities under the program based on available resources.

SB 900, as it passed the Senate, required that, for the 2017–18 fiscal year, out of funds derived from mineral extraction leases on state tide and submerged lands, including tideland oil revenue deposited into the General Fund by the commission, the sum of \$2,000,000 be transferred to the Land Bank Fund and be available, upon appropriation in the annual Budget Act, for the purpose of implementing the coastal hazard removal and remediation program. SB 900, as it passed the Senate, required that, commencing with the 2018–19 fiscal year and each fiscal year thereafter, an amount sufficient to bring the unencumbered balance of the Land Bank Fund available for the purpose of implementing the program to \$2,000,000 be transferred to that fund and be available, upon an appropriation in the annual Budget Act, for the purpose of implementing the program.

The Assembly amendments reduce those amounts from \$2,000,000 to \$500,000 for the purposes described above.

SB 909, as it passed the Senate, expanded the definition of “owned,” for the purposes of the property tax postponement program, to include the interest of a beneficiary of a special needs trust, thereby allowing claims for the postponement of property taxes on a residential dwelling the title of which is held by a special needs trust.

The Assembly amendments make technical changes to these provisions.

**Legislative Counsel's Digest of Assembly Amendments**

As it passed the Senate, SB 968 required the Public Utilities Commission to cause an assessment to be completed by no later than July 1, 2018, conducted by an independent 3rd party, of the adverse and beneficial economic impacts, and net economic effects, that could occur, and of potential ways for the state and local jurisdictions to mitigate the adverse economic impact, if the Diablo Canyon Units 1 and 2 powerplant were to temporarily or permanently shut down before the powerplant's current operating licenses expire or if the Pacific Gas and Electric Company were to decide not to pursue license renewal.

The Assembly amendments revise the language to reflect the Pacific Gas and Electric Company's announced decision that it will not seek to renew its operating licenses for the Diablo Canyon Units 1 and 2 powerplant upon the expiration of its current licenses and the company's entry into a joint proposal governing closure of the powerplant. The Assembly amendments provide that the measure is to take effect immediately as an urgency statute and require the commission to approve the withdrawal of \$400,000 from nuclear decommissioning funds established for the Diablo Canyon Units 1 and 2 powerplant pursuant to the Nuclear Facility Decommissioning Act of 1985 for use by the commission for additional staffing to urgently effectuate the third-party assessment.

**Legislative Counsel's Digest of Assembly Amendments**

SB 999, as it passed the Senate, required a health care service plan or health insurance policy issued, amended, renewed, or delivered on or after January 1, 2017, to cover up to a 12-month supply of FDA-approved, self-administered hormonal contraceptives when dispensed at one time for an enrollee, as specified. SB 999, as it passed the Senate, required a pharmacist to dispense FDA-approved, self-administered hormonal contraceptives as provided on the prescription, including a prescription for a 12-month supply, and authorized a pharmacist to dispense up to a 12-month supply at one time at the patient's request when dispensing pursuant to protocols developed by the Board of Pharmacy.

The Assembly amendments prohibit a health care service plan or health insurer, in the absence of clinical contraindications, from imposing utilization controls limiting the supply of FDA-approved, self-administered hormonal contraceptives that may be furnished by a provider or pharmacist, or at a location licensed or otherwise authorized to dispense drugs to an amount that is less than a 12-month supply. The Assembly amendments include Medi-Cal managed care plans in the definition of a health care service plan for the purposes of that provision and the coverage requirement described above, and would require the State Department of Health Care Services to seek federal approval, if necessary, and to issue all-plan letters or similar instructions to implement those provisions. The Assembly amendments instead require a pharmacist to dispense, at a patient's request, up to a 12-month supply of an FDA-approved, self-administered hormonal contraceptive pursuant to a valid prescription that specifies an initial quantity followed by periodic refills, and authorize a pharmacist to furnish, at a patient's request, up to a 12-month supply pursuant to the Board of Pharmacy protocols described above, unless it would violate existing prohibitions against unprofessional conduct. The Assembly amendments incorporate additional changes to Section 4064.5 of the Business and Professions Code made by SB 253 that would become operative only if that other bill is enacted.

SB 1091, as it passed the Senate, required an insurer to report information to the Department of Insurance regarding denial of requests for treatment under an alternate plan of care, as defined, authorized by a provision in a policy, rider, endorsement, or amendment that allows benefits for long-term care services that are not specifically defined as a covered service under the policy. SB 1091, as it passed the Senate, required the insurer to provide a policyholder or certificate holder with written notice of denial of a request for treatment under an alternate plan of care, as specified, and to make the information available to the public, upon request. SB 1091 also prohibited an insurer from designating, advertising, marketing, offering, or soliciting a policy as “family-friendly,” “catastrophic,” “short-term,” or “standardized” unless certain conditions were satisfied.

The Assembly amendments delete the prohibited insurer activities and the reporting and public access provisions described above. The Assembly amendments authorize, for specified policies, the insured or an insurer to propose an alternate plan of care, as prescribed, and define additional relevant terms. The Assembly amendments require an insurer to provide a written explanation to the policyholder or certificate holder as to the specific reason an agreement cannot be reached for policies or certificates that contain an alternate plan of care provision, as specified.

The Assembly amendments instead require the department, by October 1, 2017, to report to the Legislature on progress toward the goal of raising the Denti-Cal utilization rate among eligible child beneficiaries to 60% or greater, and to identify a date by which the department projects that utilization goal will be met, as specified. The Assembly amendments authorize the department, with the assistance of relevant stakeholders, if appropriate, to include in the report recommendations that would help it meet that goal.

The Assembly amendments require a local detention facility that does not have existing space available for in-person visitation to comply no later than January 1, 2022.

The Assembly amendments would require the notice to be given only when a person is scheduled for a service in a hospital-based outpatient clinic and would exempt from these requirements a general acute care hospital operated by a nonprofit corporation under common control with a nonprofit health care service plan that exclusively contracts with no more than two medical groups in the state to provide and arrange for medical services for the enrollees, so long as the cost-sharing design does not vary based on whether the care is provided in a hospital-based clinic or a medical office building.

SB 1384, as it passed the Senate, shifted administrative responsibilities for the California Partnership for Long-Term Care Program from the State Department of Health Care Services to the California Department of Aging. SB 1384, as it passed the Senate, required a long-term care insurance policy certified under the program to provide certain protections against loss of benefits due to inflation by offering an applicant various options at the time of purchase.

The Assembly amendments delete the provisions shifting administrative responsibilities to the California Department of Aging. The Assembly amendments require, until January 1, 2019, the formation of an executive and legislative task force, as specified, for the purpose of providing advice and assistance in implementing reforms to the program and to consider other means to assist consumers in paying for long-term care services and supports, and authorize the State Department of Health Care Services, under specified conditions, to use moneys in an existing program fund to administer the task force. The Assembly amendments revise the required inflation protection options that a certified long-term care policy must provide to an applicant. The Assembly amendments require any policy, certificate, or rider offered under the program in which benefits are limited to the provision of all care settings, except nursing facility care to be called a home and community-based services policy, certificate, or rider, to prominently identify itself as providing home and community-based services only, and to provide specified coverage.

The Assembly amendments expand the state policy supporting housing for teachers and school district employees by generally referencing Section 42(g)(9) of the Internal Revenue Code, thereby including tenants with special needs or who are involved in artistic or literacy activities within state policy. The Assembly amendments also make a nonsubstantive change.

The Assembly amendments instead require the California Environmental Protection Agency to oversee the development of a registry for greenhouse gas emissions resulting from the water-energy nexus using the best-available data. The Assembly amendments also authorize the agency to enter into a contract with a qualified nonprofit organization to develop and administer the registry, which would include, among other things, specified actions of the former California Climate Action Registry as those relate to the water-energy nexus.

SB 1324, as it passed the Senate, among other things, stated that the mission of the Department of Corrections and Rehabilitation is to promote public safety by providing a safe and constructive prison environment that fosters positive and enduring behavioral change among offenders, both in prison and after the offenders' return to the community.

The Assembly amendments delete the above-described statement and instead extend the California Victim Compensation Board's authority to grant reimbursement, as specified, for outpatient psychiatric, psychological, or other mental health counseling-related expenses incurred by the victim or derivative victim of a crime until January 1, 2019. The Assembly amendments make an appropriation by expanding the authorization for the use of moneys in the continuously appropriated Restitution Fund and impose a state-mandated local program by requiring an application for reimbursement from that fund to be submitted under the penalty of perjury.

S.B. No. 778—Allen.

### **Legislative Counsel's Digest of Assembly Amendments**

SB 778, as it passed the Senate, required an automotive repair dealer, as defined, to notify a customer who is purchasing an oil change of the recommended oil drain interval, oil grade, and viscosity in the vehicle owner's manual. The bill also required, except as specified, an automotive repair dealer to use the oil drain interval in the vehicle owner's manual in recommending the next scheduled oil change service.

The Assembly amendments recast provisions of the Automotive Repair Act as the Automotive Repair and Maintenance Act and require the registration and regulation of automotive maintenance providers, as defined, in a manner similar to provisions regarding automotive repair dealers, including requiring an automotive maintenance provider to provide a customer with a detailed written invoice for work performed and maintain records as specified.

The Assembly amendments define various terms for purposes of these provisions and recast the definition of "repair of motor vehicles" to delete the listing of various types of excluded minor services and specify that minor services do not include the changing of propulsive batteries. The Assembly amendments similarly recast the definition of "automotive technician" to delete provisions describing the specific work performed by an automotive technician. The Assembly amendments, commencing January 1, 2018, define additional terms relating to automotive repair and servicing work for purposes of these provisions. The Assembly amendments require the Director of Consumer Affairs to adopt regulations prior to January 1, 2018, defining "minor services" for these purposes and that these regulations adopted by the director, prior to January 1, 2018, continue in effect on and after January 1, 2018, as specified. The Assembly amendments prohibit a facility from registering as both an automotive repair dealer and an automotive service provider, as specified, and authorize the Department of Consumer Affairs to purchase motor vehicles for the purposes of enforcing these provisions, as specified.

The Assembly amendments revise the oil change provisions and extend their application to automotive maintenance providers.

The Assembly amendments make the operation of the bill's provisions contingent upon the enactment of AB 873 of the 2015–16 Regular Session

**Legislative Counsel's Digest of Assembly Amendments**

SB 1177, as it passed the Senate, authorized the Medical Board of California to establish a Physician and Surgeon Health and Wellness Program for the early identification of, and appropriate interventions to support a physician and surgeon in his or her rehabilitation from, substance abuse, as specified. SB 1177 also required the administering entity to have a system for immediately reporting a physician and surgeon who withdrew or was terminated from the program, to the board. SB 1177 also prohibited the use of information received, developed, or maintained regarding a physician and surgeon in the program for any other purposes. SB 1177 required the board to adopt regulations to determine the appropriate fee for a physician and surgeon to participate in the program and subjected the adoption of those regulations to the Administrative procedure Act.

The Assembly amendments authorize the board, if an investigation of a physician and surgeon occurs after the physician and surgeon has enrolled in the program, to inquire of the program whether the physician and surgeon is enrolled in the program and requires the program to respond accordingly. The Assembly amendments require the administering entity's reporting system to immediately report any physician and surgeon to the board. The Assembly amendments delete the above-described prohibition. The Assembly amendments also delete the provision subjecting the adoption of regulations to the Administrative Procedure Act.

**Legislative Counsel's Digest of Assembly Amendments**

SB 1192, as it passed the Senate, recast and revised various provisions of the California Private Postsecondary Act of 2009. SB 1192, as it passed the Senate, among other things, (1) required the Director of Consumer Affairs to appoint an enforcement monitor, no later than March 1, 2017, to, among other duties, monitor and evaluate the Bureau for Private Postsecondary Education's enforcement of the act and submit written reports to the department and the Legislature on his or her findings and conclusions, as specified, (2) increased the amount of a fine that may be issued to a person for operating an institution without proper approval to operate from \$50,000 to \$100,000, (3) required, to the extent authorized by federal law, a private postsecondary institution that does not maintain a physical presence in California and offers distance education to California students to register with the bureau and file a surety bond, as specified, (4) made a California student of a Corinthian Colleges, Inc., institution, who meets all of the other eligibility requirements, eligible for recovery from the Student Tuition Recovery Fund, and (5) established the Office of Student Assistance and Relief to, among other duties, administer the fund, serve as a point of contact to address the needs of private postsecondary students, establish an Internet Web site that contains specified information for the benefit of these students, and work, in consultation with specified state and federal agencies, to determine the extent of resources available for these students and what actions state agencies need to take to ensure the protection of the public from the closure of private postsecondary educational institutions.

The Assembly amendments, among other things, (1) delete the provisions regarding the appointment and duties of the enforcement monitor from the bill, (2) require an institution with approval to operate that knows that it is being investigated, is the subject of a judgment, a regulatory action, or increased oversight or monitoring by, or is the subject of a settlement with, an oversight entity other than the bureau to report it to the bureau, as specified, (3) revise the duties of the Office of Student Assistance and Relief established by the bill, (4) authorize the bureau to adopt, by regulation, a process that allows an institution with approval to operate to request and receive inactive status, (5) adjust annual fees charged to an institution with approval to operate, as specified, and (6) repeal the act on January 1, 2021, thereby extending operation of the act by 4 years.

### Legislative Counsel's Digest of Assembly Amendments

SB 586, as it passed the Senate, required the State Department of Health Care Services, by January 1, 2018, to contract with one or more Kids Integrated Delivery System (KIDS) networks, as defined, for the purpose of coordinating and managing the provision of Medi-Cal and California Children's Services (CCS) program services to eligible children, as prescribed. SB 586, as it passed the Senate, established criteria the department would be required to consider in selecting a KIDS network, and the eligibility standards, and qualifications and exclusions required for KIDS plan network contracts.

The Assembly amendments instead authorize the department, no sooner than July 1, 2017, to establish a Whole Child Model program, under which managed care plans served by a county organized health system or Regional Health Authority in designated counties would provide CCS services to Medi-Cal eligible CCS children and youth, and specify the department's responsibilities to participating managed care plans and eligible children under the program. The Assembly amendments exempt contracts entered into under the Whole Child Model program from a prohibition under existing law against services covered by the CCS program being incorporated into a Medi-Cal managed care contract entered into after August 1, 1994, and extend until January 1, 2022, and until the evaluation required under the Whole Child Model program has been completed, the termination of that prohibition. The Assembly amendments require the department to develop specific CCS monitoring and oversight standards for managed care plans before implementing the program in any county. The Assembly amendments require the department to establish a statewide Whole Child Model program stakeholder advisory group, as prescribed. The Senate amendments require managed care plans to meet specified requirements in order to be approved by the department to participate in the Whole Child Model program, as well as requirements applicable once the plan is serving eligible youth in a Whole Child Model County. The Assembly amendments require a specified stakeholder process to address any changes to CCS medical eligibility requirements proposed by the department.

SB 1263, as it passed the Senate, commencing January 1, 2017, prohibited an application for a permit for a new public water system from being deemed complete unless the applicant has submitted a preliminary technical report to the State Water Resources Control Board. SB 1263 allowed the state board to impose technical, financial, or managerial requirements on a permit for a public water system and would prohibit a public water system not in existence on January 1, 1998, from being granted a permit unless the public water system demonstrates that the water supplier also possesses adequate water rights to ensure the delivery of pure, wholesome, and potable drinking water. SB 1263 allowed the state board to deny a permit for a public water system if the state board determines that the service area of the public water system can be served by one or more currently permitted public water systems and prohibited a local primacy agency from issuing a permit without the concurrence of the state board.

The Assembly amendments, among other things, do the following:

(1) Allow the state board to direct an applicant for a proposed new public water system to undertake discussion and negotiation with certain existing public water systems and to require an applicant to comply before submitting an application to operate a system.

(2) Authorize the state board to deny the permit of a proposed new public water system if it determines that it is reasonably foreseeable that the proposed new public water system will be unable to provide affordable, safe drinking water in the reasonably foreseeable future.

(3) Require a person submitting an application for a proposed new public water system to first submit a preliminary technical report to the state board at least 6 months before initiating construction of any water-related improvement.

(4) Require that an applicant submit a copy of the preliminary technical report to the state board for a proposed new public water system that would be regulated by a local primacy agency.

(5) Except for a residence that will be rebuilt because of a natural disaster, prohibit a city or county from issuing a building permit for the construction of a new residential development where a source of the water supply is water transported by a water hauler, bottled water, a water-vending machine, or a retail water facility.

SB 1287, as it passed the Senate, also made other changes to the regulation of the Dungeness crab commercial fishery.

The Assembly amendments also expand the authority of the Director of Fish and Wildlife to restrict any taking of a species of fish regardless of whether the fish is taken under a commercial fishing license if the Director of Environmental Health Hazard Assessment, in consultation with the State Public Health Officer, determines that the species or subspecies of fish is likely to pose a human health risk from high levels of toxic substances. The Assembly amendments require the Director of Fish and Wildlife, after ordering the closure of any waters or restricting the taking of any species of fish, to notify the Fish and Game Commission and request that the commission schedule a public discussion of the closure or restriction at its next scheduled full meeting. The Assembly amendments remove the requirement that the closure or restriction be adopted by emergency regulation and instead exempt a closure or restriction from the Administrative Procedure Act.

The Assembly amendments also make nonsubstantive double jointing amendments by incorporating changes in Section 131052 of the Health and Safety Code proposed by SB 1473.

**Legislative Counsel's Digest of Assembly Amendments**

SB 527, as it passed the Senate, specified the administrative duties and responsibilities of the State Department of Education with respect to the administration, subject to an appropriation in the Budget Act of 2016 or another measure enacted during the 2015–16 Regular Session of the Legislature, of Safe Neighborhoods and Schools planning grants to local educational agencies, as defined. As it passed the Senate, SB 527 also set forth criteria to guide the department in awarding planning grants under the program and specified the purposes for which the planning grant funds may be used.

The Assembly amendments delete the contents of the bill as it passed the Senate. The Assembly amendments establish the Learning Communities for School Success Program for the purpose of implementing that grant program, subject to an appropriation to the Safe Neighborhoods and Schools Fund in the annual Budget Act or another measure for the purposes of the bill. The Assembly amendments specify the administrative duties and responsibilities of the department with respect to the program, including administering grants and coordinating assistance to local educational agencies, as defined. The Assembly amendments set forth criteria to guide the department in awarding grants under the program, and specify the purposes for which grant funds may be used. SB 807, as it passed the Senate, provided that a public entity, public employee, or emergency responder authorized to provide emergency services was not subject to civil liability for damage to an unmanned aircraft or unmanned aircraft system caused while the public entity, public employee, or emergency responder was providing, and the aircraft or system was interfering with, the operation, support, or enabling of specified emergency services.

The Assembly amendments limit that exclusion from civil liability to local public entities, their public employees, and emergency responders authorized by local public entities or their employees to provide emergency services. The Assembly amendments also specify that the exclusion from civil liability for local public entities and their public employees is in addition to any other immunity provided to them under law.

**Legislative Counsel's Digest of Assembly Amendments**

SB 944, as it passed the Senate, was a housing omnibus bill that, among other things, authorized the Department of Housing and Community Development to adopt guidelines related to procedures and forms to implement certain disposal procedures for a mobilehome after a warehouse lien sale and for abandoned mobilehomes until specified regulations are adopted by the department. SB 944 additionally deleted a requirement that the annual budget report prepared and distributed by the association of a common interest development include a statement describing the status of the common interest development including whether or not the common interest development is a condominium project.

The Assembly amendments, among other things, remove the deletion of the provision related to common interest development annual budget reports, and authorize the Department of Housing and Community Development to transfer any unobligated Proposition 46 and Proposition 1C bond funds in the Emergency Housing and Assistance Fund to the Housing Rehabilitation Loan Fund, less any funds needed for state operations to support outstanding awards as determined by the Department of Housing and Community Development, to be expended for the Multifamily Housing Program for supportive housing for a specified target population. The Assembly amendments additionally require the management of a mobilehome park to post and mail a notice of intent to dispose of an abandoned mobilehome within 10 days following a judgment of abandonment and require the management to file a notice of disposal with the department within 30 days following a judgment of abandonment.

SB 950, as it passed the Senate, required the arbitrator to issue a decision for each grievance.

**Legislative Counsel’s Digest of Assembly Amendments**

SB 1478, as it passed the Senate, among other things, abolished the Task Force on Culturally and Linguistically Competent Physicians and Dentists, revised the requirement that applicants for a license to practice dentistry complete the Part I and Part II written examinations of the National Board Dental Examination of the Joint Commission on National Dental Examinations by removing the references to Part I and Part II of the examination, repealed the requirement that the Medical Board of California keep a copy of a complaint it receives regarding the poor quality of care rendered by a licensee for 10 years from the date the board receives the complaint, and abolished the Bureau of Medical Statistics.

SB 1478, as it passed the Senate, also, among other things, revised provisions applicable to the California Board of Podiatric Medicine and the Board of Behavioral Sciences and made various changes to the Licensed Marriage and Family Therapist Act and the Licensed Professional Clinical Counselor Act.

The Assembly amendments, among other things, exempt, beginning July 1, 2017, licensees authorized to prescribe, order, administer, furnish, or dispense Schedule II, Schedule III, or Schedule IV controlled substances and licensed pharmacists from the annual Controlled Substance Utilization Review and Evaluation System (CURES) fee if the license has been placed in a retired or inactive status, as specified.

The Assembly amendments require specified fines collected from registered dispensing opticians to be deposited into the Dispensing Opticians Fund and to be available upon appropriation to the State Board of Optometry for the purposes of administration and enforcement.

The Assembly amendments expand certain educational requirements for a marriage and family therapist license, specify that the fee for the clinical examination required for a clinical social worker license only applies to a board-administered clinical examination and only applies if the Board of Behavioral Sciences chooses the examination in regulations, and require the board to accept education gained from an out-of-state school for purposes of satisfying the professional clinical counselor licensure or registration requirements if the education is substantially

**Legislative Counsel’s Digest of Assembly Amendments**

SB 1479, as it passed the Senate, made changes to various laws within the Business and Professions Code including, among others, the Architects Practice Act and the Contractors’ State License Law. SB 1479, as it passed the Senate, for instance, authorized the California Architects Board to grant eligibility to take the licensure examination to a candidate for licensure as an architect who is enrolled in a degree program accepted by the National Council of Architectural Registration Boards that integrates the licensure degree experience and examination components required under the Architects Practice Act, instead of a candidate who is enrolled in an Additional Path to Architecture Licensing program, as specified. SB 1479, as it passed the Senate, also deleted 2 of the conditions that cause an application under the Contractors’ State License Law for an original license, additional classification, or change of qualifier to become void.

The Assembly amendments, in addition, require a contractor performing a home improvement contract to be licensed in this state in an active status for not less than 2 years, instead of 5 years as required by state regulation, before submitting an Application for Approval of Blanket Performance and Payment Bond to the Contractors’ State License Board. The Assembly amendments further require the annual audit report of specific funds by each cemetery authority to the Cemetery and Funeral Bureau to be prepared in accordance with generally accepted accounting principles.
